### Personal Guaranty

This Personal Guaranty is of payment and not collection, and Creditor shall have no obligation to attempt to collect or enforce collection against Debtor Prior to making demand upon Guarantor hereunder. This Personal Guaranty is unconditional and subject only to those defenses that Debtor could assert to the enforcement of the debt and, thus, Guarantor waives all surety ship defenses. Guarantor agrees to remain fully bound until said debt is paid in full. The Guarantor further agrees to pay all reasonable attorneys' fees and costs necessary for the enforcement and interpret this Personal Guaranty shall be made under the laws of the State of California and jurisdiction and venue for any action to enforce or interpret this Personal Guaranty shall be in Santa Clara County, California.
